Petros Kolovos was graduated from the Faculty of Nursing, National and Kapodistrian University of Athens (2002) and the Department of Health Visitors, Technological Educational Institution of Athens (1998). He obtained a Master Degree in Management of Health Services at the Inter-University Postgraduate Program (2005) and holds a Ph.D from the Faculty of Nursing, National and Kapodistrian University of Athens (2011). On July of 2017 he was elected as an Assistant Professor in the Department of Nursing, University of Peloponnese, in the subject area of Surgical Nursing and he holds this position since April of 2018 till present.
